<b>DOT 4</b> <i>Evening delivery at a given time +/- 15 minutes</i> 	<b>05.00 PM</b> - <b>10.00 PM</b>	<p>Only by prior arrangement, contact your nearest freight terminal no later than 04.00 PM (Mon-Thu) and 03.30 PM (Fri). However, the earliest delivery time is the following evening.</p> <p>Add the agreed time to the consignment note. ## In general concerning all DOT-products

DOT deliveries cannot be booked to addresses on islands without bridges to mainland.

\*) DOT-bookings must happen in WebFragt, Consignor or another EDI.

By applying the DOT-concept, the usual Danske Fragtmænd concept of day-to-day delivery (cf. General conditions for transport § 1.4) is not applicable and the CMR Convention's rules about an agreed time limit are applied. Cf. CMR-convention § 33, payment for DOT-time delivery is not to be regarded as a fee. Compensation for special interest in the case of loss or damage, or of the agreed time-limit being exceeded requires a prior explicit and individual agreement in addition to the DOT-agreement.
